I do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Sarif Ansary S/O Ramjan Ansary of Vill - Dumdumi, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 15.02.2017 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr. SAE(E), & Sri Sasti Karmakar, Sr.L.M. of Telkalpara CCC, WBSEDCL conducted a raid programme at village Dumdumi under Purulia(M) P.S. When our team at about 12.30 P.M. entered to the Domestic premises of Sarif Ansary, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering incoming of meter and run Domestic appliances, thus original consumption was not recorded by meter and WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, the meter with bypass arrangement dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.00 P.M. after completion of inspection & necessary formalities.

Sarif Ansary S/O Ramjan Ansary of Vill - Dumdumi, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
