Sir,

I the undersigned would like to inform you that as per telephonic information received from my Departmental staff and Officer Dr. Shubhankar Bhattacharya age(45 years), BLDO Balarampur holding additional charge of Arsha Block was returning by Motot Cycle from Sirkabad (Office of the BLDO, Arsha at Sirkabad) Office yesterday(21.02.2017) after-noon on way to Purulia(Purulia Arsha Road) Arsha road at about 14.10 hours one bike ridder bearing bike number JH-09N/9353 (Passion Pro, Black Colour) clashed him face to face by way of very rush & dangerous driving. He was very much injured and from where my Departmental staff and Officer of Mobilia Veterinary Clinic who was also returning on the same path discovered & rescued him by private vehicle & the other bike ridder brought them to Deben Mahato Hospita, Purulia for their treatment from there. Dr. Bhattacharya has been shifted to Durgapur Mission Hospital for better medical management & he is still under treatment there.

Hence I request you to treat this complaint as the FIR & do the needful please accordingly.
