I do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Sri Haren Ch. Kuiry S/O Lt. Biru Kuiry of Vill -Bhul, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 02.03.2017 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr. SAE(E), Sasti Karmakar, Sr. L.M. of Telkalpara CCC & Jiaur Rahaman Mondal, AE(S&LP) of Purulia Region, WBSEDCL conducted a raid programme at village Bhul under Purulia(M) P.S. When our team at about 02.30 P.M. entered to the Domestic premises of Sri Haren Ch. Kuiry, we found that he was enjoying electricity dishonestly by means of bypassing the Energy Meter by way of tampering Service Cable, thus original consumption was not recorded by meter and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, Disconnect the tampered service wire and seized and seizure list prepared. The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 03.00 P.M. after completion of inspection & necessary formalities.

Sri Haren Ch. Kuiry S/O Lt. Biru Kuiry of Vill -Bhul, PS -Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
