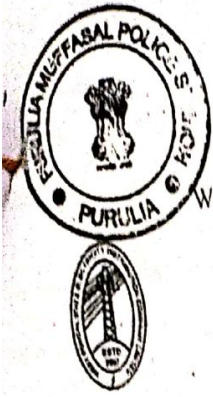

I do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Sri Sudip Kuiry S/O Lt. Hariram Kuiry of Vill -Bhul, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 02.03.2017 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr. SAE(E), Sasti Karmakar, Sr. L.M. of Telkalpara CCC & Jaur Rahaman Mondal, AE(S&LP) of Purulia Region, WBSEDCL conducted a raid programme at village Bhul under Purulia(M) P.S. When our team at about 01.30 P.M. entered to the Domestic premises of Sri Sudip Kuiry, we found that he was enjoying electricity dishonestly by means of Direct Hooking From Nearest LTOH Line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.00 P.M. after completion of inspection & necessary formalities.

Sri Sudip Kuiry S/O Lt. Hariram Kuiry of Vill -Bhul, PS -Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
