Sir,

In producing herewith one arrested accd. person namely Paresh Bouri (55) S/o Lt. Hari Bouri of Vill- Golkunda, PS- Purulia (M), District - Purulia with seized articles (1) 85 (eighty five) sealed bottles of Country Spirit styled as DIL KHUSH each Bottle contains 375 ml which were seized under proper seizure list.

I beg to submit that today (06.03.17) in between 19.05 hrs to 19.35 hrs during special raid duty acting of a secret source information myself along with force conducted raid in the house of Paresh Bouri S/o Lt. Hari Bouri of Vill- Golkunda, PS- Purulia (M), District - Purulia at Golkunda and found that the above noted person is keeping and selling country spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of liquor from his house. As such I seized 85 (eighty five) sealed bottles of Country Spirit styled as DIL KHUSH each Bottle contains 375 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presece of witnesses.

The above noted arrested accd. namely Paresh Bouri S/o Lt. Hari Bouri of Vill- Golkunda, PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of country spirit in his house.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Paresh Bouri S/o Lt. Hari Bouri of Vill- Golkunda, PS- Purulia (M), District - Purulia and arrange for its investigation.
