Sir,

In producing herewith one arrested accd. person namely Nabakumar Majhi (46) S/o Lt. Haren Majhi of Vill- Manguria, PS- Purulia (M), District - Purulia with seized articles 1) 12 (Ten) sealed bottles of foreign liquor styled as Mc. Dowell RUM each bottle contains 375 ml, 2) 08 (eight) sealed bottles of foreign liquor styled as Officer's Choice each bottle contains 375 ml, which were seized under proper seizure list.

I beg to submit that on today (06.03.17) during my night mobile duty on Purulia-Ranchi Road acting of a secret source information myself along with force conducted raid in the Line Hotel, styled as "Gourinath Hotel" near Sainik School of Nabakumar Majhi (46) S/o Lt. Haren Majhi of Vill- Manguria, PS- Purulia (M), District - Purulia at Raibaghini and found that the above noted person is keeping and selling foreign liquor which were kept in his hotel. On demand he failed to produce any valid document in respect of keeping and selling of liquor from the Line Hotel. As such I seized 1) 12 (Ten) sealed bottles of foreign liquor styled as Mc. Dowell RUM each bottle contains 375 ml, 2) 08 (eight) sealed bottles of foreign liquor styled as Officer's Choice each bottle contains 375 ml. under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses.

The above noted arrested accd. namely Nabakumar Majhi (46) S/o Lt. Haren Majhi of Vill- Manguria, PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of foreign liquor from his Hotel.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Nabakumar Majhi (46) S/o Lt. Haren Majhi of Vill- Manguria, PS- Purulia (M), District - Purulia and arrange for its investigation.
