Today, i.e. on 07.03.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) of Telkalpara CCC & Jiaur Rahaman Mondal,AE(S&LP), Sankar Chandra Mahato, L.M., and Dayamay Mahato,TSH of Purulia Region Office ,WBSEDCL conducted a raid programme. at village Chanchra under Purulia(M) P.S. When our team at about 01.30 P.M. entered to the Domestic premises of Sri Pradip Mukherjee, we found that he was enjoying electricity dishonestly by means of Direct Hooking From Nearest LTOH Line and run Domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses ,hooking wire dismantled and seized and seizure list prepared .The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.00 P.M. after completion of inspection & necessary formalities.
