10:55 hrs received a telephonic information from C/982 Shyamal Rajwar attached to Hatuara Super
Specialist Hospital that the villagers of Hatuara and Bongabari had assembled in front of the Super
Specialist Hospital at Hatuara under Purulia (M) P.S. with Lathi, Tangi, Rod etc. over the issue of taking
possession to construction work of the newly construction for Medical College beside the said Hospital.
Diarised the fact vide Purulia (M) P.S. GDE No 495 Dt. 10.03.17 and informed the superiors accordingly. I
also directed to SI Lakshmi Kanta Pati accompanied with force to work out the information. Accordingly
SI Lakshmi Kanta Pati, SI Gopal Man and ASI Manas Dutta with force left for work out the information
vide Purulia (M) P.S. Spl. C.C. No. 149/17 Dtd. 10.03.17. After reaching the spot they tried with their best
effort to pacify the mob by convincing the matter but the mob became so much violent and do not pay
any heed to the Police. Officers conveyed an information that huge number of people of both the village
Hatuara and Bongabari were coming towards the main entrance gate of the said Hospital armed with
Lathi, Rod, Axe, Katary, Stone etc. to attack each other and they were showing so aggressive behavior that
they can do any thing and every thing by taking the law in their own hand and there was every chance of
happening clash among the two villagers. After receiving the said information over phone myself being
accompanied with CI Sadar, Purulia along with available officers and men including L/C rushed to the
spot. Vide GDE No 499 and Spl. C.C. No 150/17. After reaching the spot found huge numbers of gathering
armed with Lathi, Rod, Axe, Katary, Stone etc. and were trying to assault each other of the said villages.
I tried to convince them but they were in such a adamant mood that they were not ready to listen
anything. But we somehow tried to manage the situation but failed. On several negotiation and
persuasion the villagers remain adamant and finally were trying to assault Police and became more

As a result the situation was turning to a grave one. As such to disperse the assembly I declare same as unlawful assembly and directed them to disperse. At this moment the assembly turned more violent and started to hurl stone aiming at Police with intent to kill us, they also assaulted Police with Lathi, Rod, Axe, Katary, Stone etc. having their hands. As a result SI Gopal Man, SI Lakshmi Kanha Pati, ASI Manas Dutta, ASI Salil Chakraborty, C/138 Bani Bondopadhya, C/06. Debdas Mukherjee suffer injuries on their persons and shifted them to Purulia Sadar Hospital for treatment. They also stole away two wrist watches from the Police. The unruly mob also damaged some shops beside the Purulia-Barakar Pitch Road near Bongabari. To bring the situation under control we found no other alternative rather to chase the unruly mob. Accordingly we started chasing the unruly mob by raising our Lathi and at that time the unruly mob started to retreat. At the time some of them fell down in on the rocky surface and might suffer minor injury on their persons. At that time we could manage to apprehend 19 accused persons as noted above from the PO and the normal situation restored. On being asked the persons disclosed their name and address as noted above. During search Lathi, Rod, Katary, Stone were recovered from their possession and the items were seized under seizure list. All of them were arrested issuing arrest memo and inspection memo. During interrogation of the accused persons the name of persons who fled away could be collected. The arrest was made in between 14:05 hrs and 14:45 hrs. The seizure were made in between 14:45 hrs and 16:25 hrs. I on arrival back to PS started Purulia (M) PS Case No 55/17 Dt. 10.03.17 U/S 147/148/149/186/332/353/323/325/324/307/506/379/427IPC against arrested accused persons 1.
