In producing herewith one accused person Dinabandhu Kaibartya (32) S/o-Yudhistir In producing netering of Vill-Chakoltore (Kaibartyapara), PS-Purulia Mufassil, Dist-Purulia under proper arrest with memo of arrest along with seized articles being seized under proper seizure list, enclosed herewith, 1. 18 bottles of plastic in sealed condition having printed paper being affixed on it speaking for itself as "DIL KHUSH" country sprit each bottle contains 600 ml of C.S. as per the affixed printed paper 2. 20 liters of I/D liquor (cholai) in a plustic container 3. Some polythene glass and packets including gudder 4. one bottle of "DIL KHUSH" seized as sample of Sl No- "1" 5. one bottle of glass filled up with I/d liquor (cholai) approx one (01) liter as sample of Sl No- "2" beg to report that today (10.03.17) received source information that a person had kept concealed huge stock of country liquor bottles, I/D liquor, beer etc. etc. in a hotel besides Purulia-Barabazar pitch road at Chakoltore near Chatatarh and selling the same to customers illegally as having no valid license to deal with. Accordingly I informed the matter to O/C Purulia (M) PS as myself along with ASI Chayan Mahato and available force left for to look into the matter after taking all sorts of informative action being noted the fact in G.D.E. vide Tamna OP Under Purulia (M) PS GDE no-240/17 Dtd-10.03.17 and requested my source to wait at Chakoltore more for identification of the exact shop. At 19.25 hrs we reached at Chakoltore more and as per the identification of my source we took effected entry and restrained one person after a chase as he tried to took his heel as few others manage to escape from the spot and later on , he disclosed his name and address as noted above followed by also stated that he is the owner of the hotel as well as admitted and confessed that he is engaged in selling of country spirit and I/D liquor as well as beers since long as having a huge quantity of I/D liquor and beer and accordingly we disclosed our information and for the interest of justice before starting search I called two witnesses viz. 1. Amit Ch. Mohanty S/o-Mihir Ch. Mohanty of Chakoltore (Mishrapara) PS-Purulia (M), Dist-Purulia and 2. Nirmal Mahato S/o-Madan Mahato of Koradih PS-Purulia (M), Dist-Purulia to assist us during search and seizure as they expressed willingness to became witness and the above noted articles as above seized have been seized under proper seizure list duly signed by them and also labeled as on asking he could not produce any valid license for keeping in possession, bringing, selling of such liquor. As he failed to produce any constitutional document being violated the provision of law of earth, arrested him after preparing memo of arrest duly signed by the witnesses and accd person.

Therefore, it is prayed a specific case u/s-46A (c) Bengal Excise Act 1909 may kindly be initiated against the above noted accd. person for possession, transportation and selling liquor bottles illegally in an unconstitutional channel.
