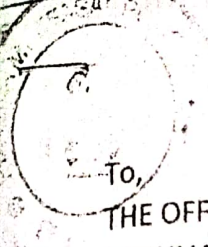

I, undersign, PROPRIETOR OF SURAJ ENTERPRISE , MAIN ROAD, PURULLIA, want to lodge a complain, (FIR) that on dated- 16-03-2017 , my goods purchased from RUCHI SOYA INDUSTRIES, RANIGANJ DEPOT, was consigned in a BOLERO PIKUP , VIDE VEHICLE NO. WB 37 C 4272, was on its way to PURULIA but near DUMURDIH village (ie., between KUSTAUR AND DUMURDIH) the vehicle was capsized and the driver sustained some injury.
