I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Subhas Das S/O Lt. Srikanta Das of Vill - Sitalpur, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 20.03.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Sri Debdas Bhattacharjee, Sr.SAE(E) of Telkalpara CCC, WBSEDCL conducted a raid programme at village Sitalpur under Purulia(M) P.S. When our team at about 03.30 P.M. entered to the Domestic premises of Subhas Das, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering service cable and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, cable with bypass arrangement dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 04.00 P.M. after completion of inspection & necessary formalities.

Subhas Das S/O Lt. Srikanta Das of Vill - Sitalpur, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
