After teng engine up the payment of such huge outstanding, the said Mr. Amit Shaw and Mrs, Nitu Shaw had now same to encount them had motives which they had in mind since the beginning which were to chest and deceme us. The said No. Amot Shaw and Mrs, Nitu Shaw have started to withhold our payment for days and then for months despite of repeated requests to them in this regard. However, after repeated pessassons and follow-ups by our officials, the accused had in order to buy time from us assured us that they would soon clear all the dues which they could not due to slow realization from the market.

Meanwhile, it is pertinent to mention here that the abovenamed accused no. 3 Mr. Rajib Roy who had been an employee in our company and who was the person who had recommended and appointed the said Mr. Amit Shaw and Mrs. Nitu Shaw for our C&F Agency, has been involved in some illegal gratification from them in the form of a percentage of commission over their sale proceeds. It is also, receiver their sale proceeds. It is also, receiver their sale proceeds. mention that the said Mr. Rajib Roy was the person who had approved numbers of unauthonced dispatches

of cement consignments to the said Mr. Amit Shaw and Mrs.Nitu Shaw on credit in gross misuse of his authority consecutively despite of non-clearance and/or repeated failures on their part to clear their earlier dues. This fact came to our knowledge while pursuing the said Mr. Amit Shaw repeatedly for payments whereby he clearly mentioned to our officials that they had been paying a percentage upon the sale proceeds to Mr. Rajib Roy to manage the situation in their favour and also to continue receiving supplies from our company on further credits. The said fact of misuse of authority by Mr. Rajib Roy had also been further verified in our Auditor's Report.

Further, the role of the said Mr. Rajib Roy, becomes more apparent by the fact that while our internal audit was being conducted and the facts of him acting in collusion and in conspiracy with the other accused came to light, he has stopped coming to our office all of sudden without informing and later he became untraceable as he started to avoid even the phone calls from our office. All this time the said Mr. Rajib Roy had been acting as hand in gloves with the other accused for his unjust, unlawful and personal enrichment at the detriment of our company.

In such circumstances, officers of our company visited the Office/Godown premises of M/s Tirupati Balaji Enterprise and met the said Mr. Amit Shaw and Mrs, Nitu Shaw who were present there and after much persuasions, they had issued certain cheques, particulars of which as follows:

They had further represented that since they were in some difficulties at that point of time, the said cheques were now handed over and could be placed for encashment on the date mentioned in the said cheques and assured that those would be honoured under all circumstances. The officials of our company duly accepted the said cheques believing upon the assurance of the said Mr. Amit Shaw and Mrs. Nitu Shaw yet again only to be duped later as when the said cheques were presented for encashment before our bank on 24.02.2017 and 27.02.2017 respectively, but the same had been dishonoured with the remark "Payment Stopped by the Drawers". This clearly reflected that the Mr. Amit Shaw and Mrs, Nitu Shaw being well aware

That further on 17.03.2017 at around 12.11 P.M. to 1.15 P.M., I have received calls from an unknown That further on 17.03.2017 at an unmber 033-28610832 and immediately upon receiving the same the person at the other end of the phone with my life. has started to abuse me in filthy language and had threatened me over the phone with my life stating that has started to abuse me in mon,
"Agar tum log shaw babu se paisa ka tagada band nahi kiya toh apna kafan ka liye paisa jutaane layak nahi

"Purulia mein baithkar tum log bach nahi payega, goli maar dega".

Upon being informed about the dishonour of the said cheque, the said Mr. Amit Shaw and Mrs, Nitu Shaw had requested the officers of our company to come to their Office/Godown premises on 18.03.2017 and they further promised to pay the amount mentioned in the cheques by way of Pay Order and/or cash. In view of such promise made by the accused persons, I along with Sri Nandan Chandra Mishra visited the Office/Godown of M/s Tirupati Balaji Enterprise on 18.03.2017 at about 10-30 a.m. When we entered the said Office/Godown, the said Mr. Amit Shaw and Mrs. Nitu Shaw told to wait in one of the corner rooms as the money was being arranged. After keeping us waiting for more than half an hour at about 11-30 a.m., Mr. Amit Shaw along with 3/4 other anti social elements, being equipped with chain and iron rods, stormed into the said room and started screaming and abusing in filthy languages by saying - "Bahut paisa ki garmi aa gya tum logo mein, aaj tumhe marke sab chukka dunga". Soon thereafter, they started beating mercilessly by fists and kicks and thereafter assaulted us with iron rods and chains. When Sri Nandan Chandra Mishra tried to resist them, at that time the said Mr. Amit Shaw suddenly wielded out a pistol from his pocket and aimed the same towards Sri Nandan Chandra Mishra and further screamed by saying - "Phone pay dham kaaney ka bhi asar nahi hua, Aaj tum logo ko marke laash ko thikane laga denge". On seeing such conduct, we started praying for mercy for our life. Hearing the same, said Mr. Amit Shaw told the others that they should not kill us if we should not demand any further money from them and agreed to sign on some blank papers. They thereafter asked us to sign on some blank papers. Finding no alternative, we signed on four blank papers and managed to escape from there though they chased us for far distance. We were so frightened about our life and suffered trauma that we decided run away and reach Purulia Directly.



Thave been tremendously terrorized by such incident and am living in complete fear of my life and limb and that of my family.

In such circumstances, it is apparent that the accused persons made false and fraudulent representations to the officers of our company with the sole intention of cheating and defrauding our company in collusion and in conspiracy with each other. Being induced by such false and fraudulent representations, our company caused supply of consignment to the company of the accused persons namely M/s Tirupati Balaji Enterprise. However, despite receiving the consignment of such huge value, the accused persons deliberately did not pay the entire value thereof and instead, tried to buy time by issuing cheques which were however, dishonoured. In fact we could come to learn subsequently that in order to induce us, the accused persons had taken us on a visit to their Office/Godown and on such date, they had run the business on hired helps in order to give an impression of great activity level in their Office/Godown. In this manner, the accused persons had cheated our company to the tune of Rs. 67,04,681/-. Our company would not have had caused supply of such huge consignment to the accused persons, if it had not been so defrauded by the accused persons and thereby suffered wrongful loss while the accused persons by misappropriating the supplied goods, have gained wrongfully. Moreover our officers were merclessly beaten up and threatened and forced to sign on blank papers, which would be used against the interest of our company.

Sir, under the facts and circumstances stated above, it is apparent that the aforesaid accused persons had misrepresented to us and had also received the misappropriated goods with the intention to cheat us with the aforesaid amount of money which they had intended to do since the inception. In the aforesaid circumstances, I request you to kindly register a First Information Report and Initiate proceeding against the aforesaid accused persons under Sections 406/409/420/324/386/387/120B of the Indian Penal Code and/or other relevant provisions of the law and apprehend the accused persons at the earliest.
