I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Md. Kamaluddin Ansary S/O Hajrat Ansary of Vill - Palanja, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 10.04.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Sri Tapan Kumar Rajwar, I.M. of Telkalpara CCC, WBSEDCL conducted a raid programme at village Palanja under Purulia(M) P.S. When our team at about 01.15 P.M. entered to the Domestic premises of Md. Kamaluddin Ansary, we found that he was enjoying electricity dishonestly by means of bypassing the energy meter by way of tampering service cable and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, cable with bypass arrangement and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.45 P.M.after completion of inspection & necessary formalities.

Md. Kamaluddin Ansary S/O Hajrat Ansary of Vill -Palanja, .PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
