person were not happy and satisfied with either cash or articles so given to the accused person.

3. That after marriage the complainant was taken to her matrimonial house by the accused person and started to ^{live} ~~live~~ there as husband and wife with the accused no.1 along with other accused persons in the same mess and house.



That out of their wedlock the complainant gave birth a male child in the year 2015 and thereafter the accused person demanded Rs. 30,000/- from the complainant for making a house and as per demand of the accused person the father of the complainant paid Rs. 25,000/- to the accused persons with a hope that the accused person will take care of his daughter and her minor son namely Aditya Gope .

5. That thereafter the accused person further demanded Rs. 30,000/- from the complainant for setting up a business the complainant informed the incident ~~to~~ to her father and knew that her father is not in a position to give such amount . Having heard the said news the accused persons started torture both mentally and physically upon the complainant and told the complainant if she will not bring the further demand of Rs. 30000/- then they will be
