Dear Sirs & Madam, I am writing to you regarding the following matter:-
On 18th August 2029 at approximately 10:00 AM, a woman was found unconscious in a residential building in our jurisdiction. She was taken to a nearby hospital where she was admitted to the Intensive Care Unit. The hospital staff informed us that she had suffered a stroke and was in critical condition. We immediately派出了警力 to the scene and initiated an investigation.
We have identified the victim as a 55-year-old woman named K. M. (Name withheld for privacy). She was found lying on the floor of her residence, unresponsive. She was conscious and able to communicate with us. She informed us that she had been experiencing dizziness and difficulty walking for the past few days. She had also suffered a minor fall a few days ago, which may have triggered the stroke.
We are conducting a thorough investigation to determine the cause of the stroke. We have interviewed the victim's family members and neighbors. We are also examining the victim's medical history and reviewing her recent activities.
We will keep you updated on the progress of the investigation and provide further information as it becomes available.
