Sir,

I SI Gopika Sundar Dutta along with C/1091 Suraj Mahato , C/1187 Samar Maity was performing mobile duty in PS area vide CC No 1742/2020 Dtd. 22.06.2020 and GDE No 947 Dtd 22.06.2020 received a telephonic information from duty officer of Purulia (M) PS at 13:25 hrs that a huge numbers of BJP Supporters were assembled in front of Purulia II Krishak Bazar and blocked the Purulia – Barakar Road (SH-5) over the issue of deputation before Agriculture Development Officer. Immediately after receiving the information I along with force rushed to the spot after being instructed by I.C Purulia (M) PS with Govt. vehicle WB38J/2320 at about 13.45 hrs. As soon as I arrived at the spot, I found that the road has been blocked totally by approx. 150 BJP supporters under the leadership of following persons namely 1. Bibek Ranga 2.Rakhakar Pandey of Bhagra 3. Satyabrata Das of Hutmura 4. Subarna Pathak of Surulia 5. Partha sarathi Mahato of Chhara 6. Anita Mahato 7. Bikash Adhikari of Raghampur 8. Sudip Pathak of Surulia 9. Dibakar Mahato 10. Dinabandhu Adhikari of Raghampur with some placards and some flags of BJP and was showing agitation on the road. I saw some of the supporters under the leadership of Bibek Ranga threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Barakar road. Subsequently I informed the matter to you. As per your instruction I asked them to show any permission of the concerned authority but they could not show any. Consequently, I asked them to call a halt of the programme but they did not pay heed on my words. Despite of all I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal. I along with force started to disperse them form the road but the road blockers obstructed us adamantly from the discharge of our public functions Thereafter they concluded the programme at 15:05 hrs. approx and dispersed. Thereafter, the vehicular traffic movement became normal after our assiduous act. They assembled on road without the permission of the concerned authority. Consequently, it reasoned to believe they violated the order and disobeyed the direction during this Pandemic situation duly promulgated by Govt. of India vide order No. 40-3/2020-DM-I (A) dated 1/5/2020 read with the order of Govt. of West Bengal vide Memo No 103-CS/2020 Dated 04/05/2020 . Subsequently it is pertinent to say that the following persons did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others. As the supra noted persons violated the order and disobeyed the direction during this Pandemic situation duly promulgated by Govt. of India vide order No. 40-3/2020-DM-I (A) dated 1/5/2020 read with the order of Govt. of West Bengal vide Memo No 103-CS/2020 Dated 04/05/2020 and did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others so they can be booked u/s 143/186/188/269/270/283/506 of the IPC & 51 of the National Disaster Management Act, 2005 and 3 of the Epidemic Diseases Act 1897 and read with section 18 W.B Highway act. 1964. So a specific case may kindly be initiated against the supra noted persons and 150 others BJP supporters and arranged for its investigation.
