Sir,

In producing herewith one arrested accd. person namely Rabi Rajwar (37) S/o Lt. Kesho Rajwar C/O-Lt. Haradhan Rajwar (Father in-law) of Vill- Satra (Bhuchungdih), PS- Purulia (M), District – Purulia with seized articles seized 02 Jarikan ID liquor containing about 25Ltrs. each and 10 bottels of Country Spirit styled as DILSE each Bottle contains 600 ml which were seized under proper seizure list.

I beg to submit that today (08.05.17) during special raid duty acting of a secret source information I along with force conducted raid at house of Rabi Rajwar (37) S/o Lt. Kesho Rajwar of Vill- Satra (Bhuchungdih), PS- Purulia (M), District – Purulia and found that the above noted person is keeping and selling ID liquor which were kept at his house. On demand he failed to produce any valid document in respect of keeping and selling of ID liquor from at his house. As such I seized 02 Jarikan ID liquor containing about 25 Ltrs. each and 10 bottels of Country Spirit styled as DILSE each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presece of witnesses.

The above noted arrested accd. namely Rabi Rajwar (37) S/o Lt. Kesho Rajwar C/O-Lt. Haradhan Rajwar (Father in-law) of Vill- Satra (Bhuchungdih), PS- Purulia (M), District – Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of ID liquor and country spirit from his house.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Rabi Rajwar (37) S/o Lt. Kesho Rajwar C/O-Lt. Haradhan Rajwar (Father in-law) of Vill- Satra (Bhuchungdih), PS- Purulia (M), District – Purulia and arrange for its investigation.
