Sir,

In producing herewith one arrested accd. person namely Akash Mahato (22 yrs) S/o Swapan Mahato Vill- Belgaum Mahato Para (Near Chandmari Danga), PS- Purulia (M), District - Purulia with seized articles 38 Bottles of Country Spirit styled as DILKHUS, each Bottle contains 600 ml which were seized under proper seizure list.

I beg to submit that today i.e. (17.05.17) during special raid duty acting of a secret source information at 14:15 hrs I along with force conducted raid at PAN Gumthi at Belgaum Mahato Para (Near Chandmari Danga) of Akash Mahato (22) S/o Swapan Mahato Vill- Belgaum Mahato Para (Near Chandmari Danga), PS- Purulia (M), District - Purulia and found that the above noted accused person is keeping and selling ID liquor which were kept at his PAN Gumthi. On demand he failed to produce any valid document in respect of keeping and selling of ID liquor from his PAN Gumthi. As such I seized 38 Bottles of Country Spirit styled as DILKHUS each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses.

The above noted arrested accd. namely Akash Mahato (22) S/o Swapan Mahato of Belgaum Mahato Para (Near Chandmari Danga), PS- Purulia (M), District - Purulia committed offence u/s 46 A ( c ) B.E.Act. 1909 for unauthorized possession and sale of ID liquor and country spirit from his PAN Gumthi.

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Akash Mahato (22) S/o Swapan Mahato of Belgaum Mahato Para (Near Chandmari Danga), PS- Purulia (M), District - Purulia and arrange for its investigation.
