Sir,

This is to state that I, the under-signed is the elder sister of Indrajit Chatterjee son of Late Biplab Kumar Chatterjee and he was now aged about 36 Years and employed in sales/marketing and he sometimes use to visit the neighbouring district for his employment and at present he was residing with his wife namely Kaberi Roy (Chatterjee) (Daughter of Ramhori Roy), whose paternal house was at Village: Naranpur, Sorbori, P.S: Neturia, District: Purulia.

My brother and his wife had developed intimacy during while he was student and ultimately get married in 2004 without informing us and thereafter de-touched himself from his paternal family initially but after few years, specially at the death of my father in 2008 came in touch with us. They were blessed with a child in June 2005, whose name is Luckey.

My brother for last few years settled at Napit para locality of Purulia Town and thereafter started opened his mind and for number of times he used to state that his wife, his parents inlaws, both of his sister in-laws and their respective husbands started inflicting physical and mental torture in various manner and he use to repent that only for them he had severed his relationship with his paternal family. In the meantime, as stated by my brother, that his wife had also developed some illicit and immoral relationship with one Netai Chatterjee @ Rajesh, who is an employee of Kolkata Police and he had gave threats to his life.

On 8.2.2017, the son of my brother, Luckey, gave me a phone call and stated that his father is behaving in a peculiar manner and her mother and said Netai and others had physically assaulted him (Luckey).

I then called my brother on 9.2.2017 and asked for his condition to which he reported that he is in a distress. his wife and in-laws are creating various types of torture. Said Netai had

18.02:2017 ficer-in-charge threatened him on the point of gun and asked to go for divorce from his wife. His wife also demanded Rs. 5 lakhs and to get himself divorced. I had asked my husband to see my brother, to which he reported that the rented house of my brother is under lock and key. I tried to contact my brother over phone, but could not do so. His room remained under lock and key.

Ultimately on 11.2.2017, from the daily news paper (Ananda Bazar Patrika), I came to learn that my brother had committed suicide at a Hotel at Bankura. I, myself and my family members were very much busy with last rites of my brother, to control my widow and aged mother and mentally perturbed over the untimely death of my brother, I could not inform the fact to you at any early occasion.

I, accordingly, demand justice and punishment for the offenders who had abated the death of my brother. I have my firm conviction that the wife of my brother, her family member and said Netai@ Rajesh had conspired all together for such abatement.
