Sir,

In producing herewith one Kalyan Sen (43 yrs) s/o Amarendra Nath Sen of Nadiha (near Misti Mahal), PS- Purulia (T), Dist- Purulia, along with seized Liquor "Dil Se" having strength 80° UP -74 bottles (600 ml each @ Rs 32/- per bottle), total 44.4 Ltrs & value Rs 2368/- & all bottles are sealed as printed in the label pasted on the bottle. I, ASI- Goutam Bangal of Purulia (T) PS do here by lodge complaint that, on 06.03.2017 at 18:45 hrs received source information that, the above noted accused person is unlawfully selling Liquor at his hotel styled as "Basanta Hotel". Accordingly I informed the fact to O/C, Purulia (T) PS and as per direction myself along with force with Govt. vehicle No. WB 56C 9388 had been at Telkalpara, Purulia, PS- Purulia (T), Dist- Purulia, and held a raid in the hotel of the above accused person.

Reaching the hotel it was found that, one person holding a bottle like "Dil Se" fled away in the dark. Being asked, the above accused person revealed that he was selling Liquor bottles to that person. Seeing the Police party, the customer fled away and disappeared in the darkness. On searching, the above seized articles were recovered from the possession of the above accused person. On interrogation, he confessed his guilt for unlawfully possessing such Liquor and also produced Rs. 32/- as selling amount of one 600 ml bottle of "Dil Se", which was also seized.

Accordingly, I seized the same after preparing a proper seizure list duly signed by my accompanying Police Force as well as I got it signed by the arrested person and also duly labeled.

As the accused person under such circumstances committed an offence in contravention of Section 18(1) & punishable U/S 46A (c) Bengal Excise Act, so I arrested him after disclosing his ground of arrest after issuing arrest memo etc.

I, therefore, pray that, a case U/S 46A (c) Bengal Excise Act may kindly be started against the above noted accused person and also for arranging its investigation.
