Sir,

In producing herewith 02 arrested accused persons namely (1) Amrit Kumar @ Chhotu Behera (25 yrs) s/o Pasupati Kumar of Vill.- Satra, PS - Arsha, Dist - Purulia, (2) Jagannath Mukherjee (26 yrs) s/o Satyanarayan Mukherjee of do, with following seized articles (1) One crowbar, (2) Nylon rope approx 25 ft long & one iron rod, (3) one Bhojali (big knife), that today (06.03.2017) at 21:45 hrs in course of my mobile duty (vide Purulia (T) PS GDE No dt 06.03.2017) I received secret information from a source that a gang of criminals comprising of 8/9 heads under the leadership of Amrit Kumar @ Chhotu Behera of Vill.- Satra, PS - Arsha, Dist - Purulia, assembled at behind the 40 Quarter at Dulmi - Nadiha, PS-Purulia (T) being armed with deadly weapons etc with a view to commit dacoity at the houses at 40 Quarters area.

Accordingly I informed the matter to O/C Purulia (T) PS, over phone and accordingly briefing to all my accompanying force I immediately along with source and C/248, Renghu Mahato, C/330, Banamali Soren, C/988, Maheswar Kora vide Purulia (T) PS CC No 808, dtd 06.03.2017, left for to work out the information with Govt. vehicle No WB 56C 5421. At 22:05 hrs we reached at the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 50 yards we cordoned them. Their whispering came to our knowledge regarding committing of dacoity at the houses at 40 Quarters. We crawled nearer to them and disclose our identity and asked them to surrender; at that time, they all started to fled away, we chased them by using dragon light device. After a hot chase we could able to apprehend (1) Amrit Kumar @ Chhotu Behera (25 yrs) s/o Pasupati Kumar of Vill.- Satra, PS - Arsha, Dist - Purulia, (2) Jagannath Mukherjee (26 yrs) s/o Satyanarayan Mukherjee of do, as identified on interrogation. On further interrogation they stated that they along with 6/7 unknown other were assembled there and preparing themselves for committing dacoity at the houses at 40 Quarter area. We searched the above persons and following items were recovered from their possession, as (1) One crowbar & Nylon rope about 25 foot length from the possession of Jagannath Mukherjee, (2) one Bhojali from the right hand of accused Amrit Kumar @ Chhotu Behera & one small torch from his left hand. On demand, they failed to give any satisfactory explanation in respect of their presence in this area in the dead hours of night with such deadly weapons. So it is crystal clearly that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 399/402 IPC. As such 22:45 hrs to 23:2: hrs on 06.03.2017, the above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accuse persons. As no public witnesses were present at the abandoned area thus seizure list was signed by the accompanied officers and force.

On return to PS, I lodge complainant against (1) Amrit Kumar @ Chhotu Behera (25 yrs) s/o Pasupati Kumar of Vill.- Satra, PS - Arsha, Dist - Purulia, (2) Jagannath Mukherjee (26 yrs) s/o Satyanarayan Mukherjee of do & 6/7 unknown others for starting a case U/S 399/402 IPC and also arranging its investigation.
