The main purpose of the Ceragem Centre is to sell the machine amongst the people those who are benefitted from their diseases by taking free ~~trial~~ trial basis therapy in the Centre for unlimited days.

So when I have got much benefitted by taking Spinal Management Therapy with this machine I have booked RL-1 machine for myself in Purulia Centre by giving 1.49 lakh as an advance. Money receipt of this amount is given to me by Centre.

But it is a matter of great regret that all on a sudden the centre is closed completely by the owner of Shri Subodh Singh perhaps in the month of September 2016. Address of Shri Subodh Singh is given here.

Again I am informing you with a great sorrow that the owner Shri Subodh Singh neither has returned the advanced amount which I booked nor has delivered the machine to me till now. The owner Subodh Singh left Purulia after closing the Centre in the month of Sept 2016.



Now again it is brought to your kind notice that you are not only the victimised person alone but also other persons are there along with me who are victimised like me in the same way. Their mobile no is given below along with booking amount given as an advance.

Therefore it is my heartiest request to you to take immediate strong legal action against the owner Shri. Soboth Singh in such a way that either we should get back our advanced amount which he booked or Machine should be delivered to us without fail very quick. We will remain grateful to you forever if you kindly do the needed action against him in favour of me and us.
