Entered the premises of Sri Asit kumar kundu s/olate gunucharan kundu, Dulmi Nadiha, PS- Purulia (T) present user of Meter no - 750281299 Conn Id - 242003065 which was in the name of Late Trilochan kundu

Received on 21/03/17 at 5:05 pm and inspected his/her premises. During inspection theft of electricity was detected. i.e. he/she was using electricity dishonestly by direct hooking <sup>tapping</sup> from the nearest LT over head line and further to mention that power supply to the said premises was disconnected due to non payment of electricity bill, and therefore he/she was enjoying electricity dishonestly, i.e. U/S 135(1)(a) and 138(1)(b) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) Refrigerator - 01 no
- 2) Fan - 06 nos. , Bulb - 01
- 3) Tube - 06 nos.
- 4) TV - 01 no , Pump - 01 no.

out of which I seized the following

1. P.V.C 2 core service connection wire - 2' (approx)
2. Holder 01 no with Bulb
3. Meter - 01 no (750281299)

Seizure list was prepared at the site and the accused person refused to sign/signed the seizure list.

The inspection team left the premises at 12:50 Pm on 21/3/2017. The accused person has committed an offence U/S 135(1)(a) and 138(1)(b) of The Electricity Act-2003 & subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
