I, SI Dipankar Sarkar, O/C Purulia (T) PS, do hereby lodge a complaint as suo - motu against approx 100 villagers of Maguria village under Purulia (M) PS, Dist- Purulia, that today (05.05.2017) morning, getting information regarding sudden gathering of people at Judge Bunglow morh, myself along with ASI Nirod Mahato, ASI Prasanta Sanyal, (i) C/500 Shyam Sundar Deshmukh, (ii) C/906, Haralal Gorai, (iii) C/858, Subhas Ch Punuria, (iv) C/50, Dharani Dhar Mahanty went to Judge Bunglow morh and found that approx 100 villagers of Maguria village under Purulia (M) PS, had obstructed Purulia – Ranchi (NH 32) road and Purulia – Bankura (MN 60A) road at Judge Bunglow morh under Purulia (T) PS at 08:45 hrs and vehicular traffic was getting disrupted. Ongoing buses, trucks and other vehicles were stopped remitting all people got stuck. They raised slogans against the Govt. for anti people policy. A tumultuous situation occurred and after several request of me, the agitators did not pay any heed to withdraw the blockade. Finding no alternative I declared the mob as unlawful assembly and asked them to disperse, though they did not pay any attention. As we were scanty in number, so I prayed for reinforcement.

Meanwhile, Sri Tapan Kr Bandopadhyay, the Jt BDO, Purulia – 1 Development Block arrived at that spot and after prolonged discussion with them, they withdrew the blockade at 10:00 hrs and decamped calmly. Vehicular traffic became normal.

As those persons have committed an offence as noted above, hence returning to PS I recorded Purulia (T) PS Case No 62/17 dated 05.05.2017 U/S 143/341/283/506 IPC & 18, W.B. Highway Act 1964 and directed SI Subal Goswami for its investigation.
