Sir,

With due respect I SI Bapan Mondal, beg to submit before you that on 24.06.2020 at about 20:45 Hrs while was on raid duty against without mask of pedestrian with assist of Evening patrolling mobile duty officer SI Maniur Rahaman and forces vide Purulia (T) PS C.C. No- 1484/20 dated- 24.06.2020 at Deshbandhu Road in front of Big Bazar and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal circular. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested from 21:05 Hrs. to 21:55 Hrs. after maintaining all formalities regarding arrest and brought them to P.S
