Sub: Intimation for lodging of FIR.

Sir,

This is to bring to your kind notice that it is appears from the application submitted by Shri Kalipada Maji of Village – Ghoratika, P.O.- Dhadka, P.S.- Bandwan, Dist- Purulia that one Shri Ajoy Bouri of Vill & P.O.- Kushi, P.S.- Jhalda, Dist- Purulia has supposedly cheated him dishonestly. The following documents have been submitted by Shri Maji, which supports these claims.

1. Complaint letter of Shri Kalipada Majhi dated 08/08/2017 addressed to the DL&LRO, Purulia.
2. Letter of Shri Kalipada Majhi dated 22/02/2017 addressed to the DL&LRO, Purulia.
3. Letter of Shri Ajoy Bouri dated 07/07/2017.
4. Copy of the plot information of Plot No 1, Mouza: Ghoratika, JL No 124, PS Bandwan.

From the above documents, there are reasonable grounds for the undersigned to believe that Shri Maji seems to have been cheated by Shri Bouri through personation, by impersonating himself as a staff of this office.

Also, Shri Bouri has used the round seal and signature of DL&LRO, Purulia. Whereas, Shri Bouri, is not a staff of this office, neither was authorized to use the seal of this office in any capacity whatsoever nor was he officially given access to any such materials from this office. Apart from fraudulently making the seal of this office, he also seems to have forged the signature of the undersigned, denoted as "Apd" dated 22.02.17.

Using all these false means, Shri Bouri seems to have promised Shri Maji, to deliver mutation for the parcel (Plot No 1, Mouza: Godhoratika, JL No 124) of land located. Shri Bouri has convinced Shri Maji that the forged documents are genuine one.

Considering all above, the undersigned is apparently convinced that Shri Bouri has committed offence under Section 420, Section 416, Section 463, Section 464 Section 468 and Section 471 of IPC.

This letter shall be treated as F.I.R. for taking appropriate legal action against Shri Bouri. As such the office of the undersigned offers critical services of the Land and the Land reforms Department, on behalf of the Government of West Bengal. Many poor people in the Purulia district avail the services of this Department, forging of signature of high official such as the District Land and Land Reforms Officer and duplicating the seal of such high office, causes a serious threat that could erode the public perception of this office. Therefore, you are kindly request to take swift and strong action against the perpetrators of such crimes.
