Sir,
In producing herewith 07 (Seven) arrested accused persons namely (1) Saksena Mudi (20 yrs) s/o Nemai Mudi of Naranpur, PS-Joypur, Dist- Purulia, (2) Pritam Mudi (21 yrs) s/o Nemai Mudi of do, (3) Satrugan Mudi (22 years) s/o Nemai Mudi of do, (4) Subhas Bed (35 yrs) s/o Lt Sambhu Bed of Golkunda, PS-Purulia (M), Dist-Purulia, (5) Kanti Dey (48 yrs) s/o Late Naran Dey of Lodhurka PS- Hura, Dist- Purulia, (6) Hanan Ansary (40 years), S/o- Babu Anasry, of Golkunda, PS- Purulia (M), Dist- Purulia (7) Shibu Bed (28 years) s/o Lt Sambhu Bed of Bara Idga, PS- Para, Dist-Purulia, with following seized articles (1) One country made improvised Fire Arms loaded with one round live ammunition (2) One crowbar & Nylon rope about 25 foot length (3) 02 Bhojali (4) one small torch (5) One Lathi having 5ft length (6) One Iron Rod (7) One Iron cutter (locally known as 'Ari'), that today (18.05.2017) at 01:05 hrs in course of my night mobile duty (vide Purulia (1) PS GDE No-418 dt 17.05.2017) I received secret information from a source that a gang of criminals comprising of 9/10 heads under the leadership of Saksena Mudi (20 yrs) s/o Nemai Mudi of Naranpur, PS-Joypur, Dist- Purulia, being armed with deadly weapons etc with a view to commit dacoity at the houses at Indraprastha colony area.

Accordingly I informed the matter to O/C Purulia (T) PS, over phone and contacted with all night patrolling officers, briefing to all I immediately along with source and ASI Sk. Guljar, C/599 Sk. Ramjan, C/559 Tarani Prasad Majhi and others officers & forces, left to work out the information with Govt. vehicle No WB 56C 5421. At 01:25 hrs we reached at the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 50 yards we cordoned them. Their whispering came to our knowledge regarding committing of dacoity at the houses at Indraprastha colony area. We crawled nearer to them and disclose our identity and asked them to surrender; at that time, they all started to fled away, we chased them by using dragon light device. After a hot chase we could able to apprehend (1) Saksena Mudi (20 yrs) s/o Nemai Mudi of Naranpur, PS-Joypur, Dist- Purulia, (2) Pritam Mudi (20 yrs) s/o Nemai Mudi of do, (3) Satrugan Mudi (22 years) s/o Nemai Mudi of do, (4) Subhas Bed (35 yrs) s/o Shambhu Bed of Golkunda, PS-Purulia (M), Dist-Purulia, (5) Kanti Dey (50 yrs) s/o Late Narayan Dey of Lodhurka PS- Hura, Dist-Purulia, (6) Hanan Ansary (40 years), S/o- Babu Anasry, of Golkunda, Ps- Purulia (M), Dist- Purulia (7) Shibu Bed (28 years) s/o Shambhu Bed of Boro Idga, PS- Para, Dist-Purulia, as identified on interrogation. On further interrogation they stated that they along with 9/10 unknown other were assembled there and preparing themselves for committing dacoity at the houses at at Indraprastha colony area. We searched the above persons and following items were recovered from their possession, as (1) one country made improvised Fire Arms loaded with one round live ammunition have been seized from the exclusive possession of Satrugan Mudi as on demand he failed to produce any document or license in respect of possession of such Arms & ammunition, (2) One crowbar & Nylon rope about 25 foot length from the possession of Subhas Bed, (3) one Bhojali from the right hand of accused Shibu Bed (4) one Lathi (approx 5 ft) from the possession of Saksena Mudi (5) One Bhojali from the possession of Hanan Ansary (6) One Iron Rod from the possession of Kanti Dey (7) One Iron cutter (locally known as 'Ari') & small torch from the possession of Pritam Mudi. On demand, they failed to give any satisfactory explanation in respect of their presence at that area in the dead hours of night with such deadly weapons. So it is crystal clearly that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 399/402 IPC & 25/27 Arms Act. As such 02:05 hrs to 04:05 hrs on 18.05.2017, the above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons. As no public witnesses were present at the abandoned area thus seizure list was signed by the accompanied officers and force.

On return to PS, I lodge complainant against (1) Saksena Mudi (20 yrs) s/o Nemai Mudi of Naranpur, PS-Joypur, Dist- Purulia, (2) Pritam Mudi (21 yrs) s/o Nemai Mudi of do, (3) Satrugan Mudi (22 years) s/o Nemai Mudi of do, (4) Subhas Bed (35 yrs) s/o Lt Sambhu Bed of Golkunda, PS-Purulia (M), Dist-Purulia, (5) Kanti Dey (48 yrs) s/o Late Naran Dey of Lodhurka PS- Hura, Dist- Purulia, (6) Hanan Ansary (40 years), S/o- Babu Anasry, of Golkunda, PS-Purulia (M), Dist- Purulia (7) Shibu Bed (28 years) s/o Lt Sambhu Bed of Bara Idga, PS- Para, Dist-Purulia & 2/3 unknown others for starting a case U/S 399/402 IPC & 25/27 Arms Act and also for arranging its investigation.
