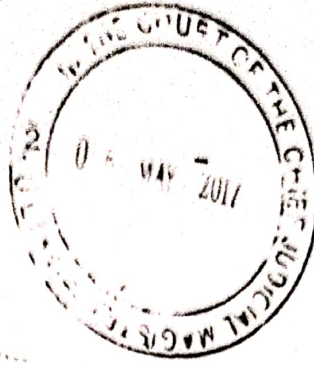

- 2). That the injured is a machanic and running a Motor cycle garage at old Police line within P.S. Purulia (T), Dist - Purulia.

- 3). That on 03.05.2017 at about 11 A.M. when the injured was busy at his garage at that time Same Bibi, wife of Sajid 2. Sk. Murtaja son of Sk. Alijan, 3. Noor Mohammad son of Sk. Yadali 4. Masum Sk. son of Sk. Mannar 5. Sk. Mahboob son of Sk. Mannar 6. Bablu and 7. Fakru and some others forcibly entered the Garage and started to broke down the equipment of the Garage and snatched Rs. 2,000/- from the pocket of the injured Sk. Raju as a result of it sk. Raju's pocket is torn.
- 4). That later accused persons collect one Iron rod from the garage and hit at the chest and gender and another accused hit by punch to the injured at his chest, and all the accused persons hit the injured by leg. The aim of the accused person to bring the injured to Jhalda and kill him. But some how the injured came to know about the plan of the accused persons and tried to fled away from the spot, and with the support neighbour the injured succeeded to save his life.
- 5). That later the local people shifted the injured to Deben Manabo Sadar Hospital Puculia and attending Doctor admitted him in the said hospital.
- 6). That now the condition of the patient is very serious and till today he neither response nor speak.
- 7). That after the occurrence the information is served to Puculia (W), P.S. but they have no taken any action against the accused persons.
