Sir,

In producing herewith one arrested accd. namely Ganesh Swarnakar (23 yrs) s/o- Lt. Sankar Swarnakar of Swarnakar Mohalla, PS- Chas, Dist- Bokaro, Jharkhand, with Arrest Memo, Inspection Memo and seized articles viz (1) one iron made single bore country made fire arms having length of 22cm (approx) with butt, barrel, firing pin, trigger etc. having length of barrel 12 cm (approx) and (2) one live ammunition of .303 rifle under proper seizure list and being labeled properly, I beg to inform you that today (28/05/17) at 22:07 hrs, received a telephonic information from my reliable source that one youth aged about 23 years was seen loitering at Ketika near Jal Tanki, under Purulia(T)PS and a careful observation from the closet point of view something like the butt of a small fire arms was seen at his waist being kept supported with his pant and it was his firm belief that it was nothing but a fire arms. I asked him to eye upon the suspicious person, diarized it vide Purulia(T)PS G.D.E No 1035 Dtd 28/05/17 and consulted with O/C Purulia(T) PS and as per his direction at 22:15 hrs, I, along with ASI Prasanta Sanyal ASI Sukhendu Mondal, C/1272 Bikash Ch. Patra, C/437 Subal Ch. Mondal, C/497 Ambuj Kr. Mondal and C/77 Hemanga Pati started for working out the information (vide CC No 1786/17 Dtd 28/05/17) after briefing them properly about the gravity of the information and my plan to nab him. We reached a Ketika at around 22:35 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching there, my source identified the person by gesture from a distance and we apprehended one youth and on asked he identified himself as Ganesh Swarnakar (23 yrs) s/o- Lt. Sankar Swarnakar of Swarnakar Mohalla, PS- Chas, Dist- Bokaro, Jharkhand and I disclosed him about the information. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly. After that on searching one iron made single bore country made fire arms having length of 22cm (approx) with butt, barrel, firing pin, trigger etc. The radius of the barrel is 04 mm (approx), the length of the barrel is 12 cm (approx) and was recovered from his exclusive possession and on opening the fire arms one live ammunition of .303 rifle was recovered as being loaded in the fire arms. On asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms. So I seized the above narrated fire arms and ammunition from his possession under proper seizure list and also labeled them separately, but no public witness could be made available there at night. After seizure I arrested him at 23:25 hrs observing all the formalities regarding arrest as his offense comes under the purview of Indian Arms Act.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
