This is to inform you that I, the undersigned has been posted as Judicial Magistrate, 2nd Court, Purulia vide the Hon'ble High Court's Appellate Side, Calcutta, Notification No.5327-A dated 02-12-16 and as such, presently I am residing at Flat No.201 (2nd Floor), Narayani Complex, Saheb Bandh, Opposite Science Museum, Purulia-723101. I further like to draw your attention that on 29-05-17 at around 6:00 P.M. to 6:30 P.M., one of our maids namely Anjana Bagdi has come to our house for cleaning utensils as usual. On being asked by my mother, Smt. Bani Paul whether she can put oil and give a massage to her or not, she has replied in the affirmative.
