During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

FAN - 0.5 nos., Tube Light - 0.5 nos.

8 f.t. - 0.3 nos.

Refrigerator - 01 no., Water Pump - 01 no.

The accused person has committed an offence U/S135(I) (b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
