Entered the premises of Sri Ashish kumar Das of Rashmela, P.O+P.S. Purulia Dist- Purulia, having Consumer No. 242024988 Meter No. B3906218 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- FAN - 05 nos.
- Tube Light - 05 nos.
- Refrigerator - 01 no.
- Water Pump - 01 no.

Out of which I seized the following:

① Cutting/By-passing portion of incoming stc cable - 4 ft (approx) along with wire.
② Bypass Arrangement with Cut out & Steel cl

Seizure list was prepared at the site and accused person refuse to sign/sign. The inspection team left the premises at 12:37 P.M. on 02/6/2017. The accused person has committed an offence U/S135(I) (b) of the electricity act-2003 subsequently electricity (Amendment) act.- 2007.
