I Shri Satyendra Singh s/o Late Pancham Singh residing at Kapur Bagan near rice mill, purulia barakar road, ward no 21 P.O- Purulia P.S.- Purulia Dist. - Purulia beg state that I am residing in my said address with my wife and one son and one daughter is Simran Kumari aged about 16 years has appeared in the madhyamik examination this year. My daughter since last about one month was engaged in giving Tution about 4 children in the house of Shri Manav Jaiswal in the Goshala more. She used to go in the house of Manav Jaiswal in the morning at about 8.30 AM and used to return at about 11 AM. On 28.05.2020 as usual she went out taking BSA cycle for giving Tution but she did not returned home as usual time for which I myself, my son Mohit Singh and some of my known persons made search in the above house of Manav Jaiswal who told us that Simran came and left his house as usual. But on our searched we could not find my daughter. I came to know that my daughter took with her about RS 3000-4000. In course of our searched I went to Big bazaar and found her BSA cycle was kept outside the big bazaar. So we asked the security guard there Mr Pappu about my daughter who told us that Simran with another girl kept the cycle there and went way. It is mention that one Roshni Roy of North Lake Road near raghavpur was a friend of my daughter and they used to mix each other.

On our frantic search till now we could not find my daughter Simran Kumari for which I am lodging this complain before you and request you to take cognizance of this and find out my daughter and return her to me.

And for which at kindness shall be ever grateful to you. The description of my daughter is age about 16 years, fair complexion, height medium, language Hindi and black mole on the back side of neck.
