With due respect I SI Bapan Mondal, beg to submit before you that on 20.06.2020 at about 19:45 Hrs while was on Evening Patrolling mobile Duty with ASI Shadhan Ch. Danda and forces at Haripada Sahitya Mandir and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal circular. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested from 20:05 Hrs. to 21:35 Hrs. after maintaining all formalities regarding arrest and brought them to P.S
