


The humble Petition on behalf of the above named complainant;

Most respectfully sheweth: -

- That on January, 2015 the above-named accused searched for a purchaser to sale some land adjacent to his house situated at Nadiha due to his some financial crisis.
- That the complainant met with the accused and expressed his desire to purchase the land of the accused.



- That the description of the property is as follows Dist. Purulia, Mouza Nadiha, J.L. No. 291/3, P.S. Purulia (T), Holding No. 1112, Ward No. 7, R.S. Khatian No. 356, R.S. Plot No. 2696, admeasuring 2 kathas.
- That the valuation of the land has been fixed at Rs. 2,10,000/-(Rupees two lacs ten thousand) only.
- 5. That accordingly on 21/02/15 the complainant paid a sum of Rs. 2,00,000/- (Rupees two lacs) only to the accused as an advance money and an agreement has been executed being SL. No. 20/15 dated 22/01/15 before the Notary Public namely Binod Kumar Sao (Advocate) at Purulia District Judge's Court. On the said agreement both the complainant and the accused and the witness put their signatures and those signatures have been identified by the Ld. Advocate Subhasis Ganguly.
- That as per agreement rest Rs. 10,000/- (Rupees ten thousand) only will be paid by the complainant to the accused and the accused will execute the sale deed within three months from 22/01/15.
- 7. That after lapse of 15 days the complainant approached the accused to receive the rest sum of Rs. 10,000/- (Rupees ten thousand) only and to execute the Registered Sale Deed. But the accused deferring the matter by giving various excuses. The complainant also approached the accused to return the advance money but the accused did not do so.
- 8. That thereafter the accused sent a Legal Notice through Ld. Advocate and in reply of the said Legal Notice the accused denied about taking a sum of Rs. 2,00,000/- (Rupees two lacs) only as an advance money from the complainant and replied that the accused took a sum of Rs. 10,000/- (Rupees ten thousand) only as a loan.
- That thereafter the complainant understood that the accused playing fraud with him and trying to misappropriate the money of the complainant.
- 10. That the complainant informed the matter to the Officer-in-Charge of Purulia (T) P.S. but the police personnel refused to lodge any information.



11. That thereafter on 06/12/16 the complainant sent a letter to the Superintendant of Police, Purulia in the self same incident but no specific case has yet been started against the accused. So, the complainant compelled to file this petition before your Honour's Court for proper justice and to treat this petition as an F.I.R.

It is therefore, prayed that your Honour will graciously be pleased to forward the instant petition of complain to the Officer-in-Charge of Purulia (T) P.S. with a direction upon him to cause investigation into the case U/S 156(3) Cr.P.C. and further be pleased to pass necessary orders as your Honour deem fit and proper.
