In producing herewith the O2persons namely (i) Sanjib Kr. Mahato (28 yrs) s/o Lt. Ajit Prasad Mahato & (ii) Bablu Mahato (38 yrs) s/o Lt. Satrughan Mahato both of Vill-Dumdumi, PS- Purulia (M), Dist- Purulia along with 01 motorcycle along with memo of arrest issued against each and the 01 seizure list before you. The fact of the case in a nut shell is that I SI Sk Ismail Ali along with force namely 1) JC/950 Goutam Betal 2) JC/783 Susanta Panda & C/236 Ramchandra Gorain was performing the Naka Checking duty vide Purulia (M) PS GDE No 1304 dated 27.06.2020 in consonance with C.C No 1797 Dtd. 27.06.2020 as per order of superior at Aimundi More near Pandey Hotel from 22:15 hrs and onwards. I intercepted the supra noted persons at 00:35 hrs on the following day and asked them regarding the reason of their circumambulation on the road at the night curfew. On being asked they could not give sufficient reason or satisfactory answer of their circumambulation on road at the night curfew. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of India vide Order No. 40-3/2020-DM-1/(A) Dtd. 01.05.2020 read with order of Govt. of West Bengal Vide Memo No 103-CS/2020 dtd. 04.05.2020. Subsequently it is pertinent to say that the supra noted persons did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them and seized their new Motor cycle styled as Black colour Bjaj Pulsar having Eng. No DHXRLB63053 & Chassis No MD2B64BX2LRB06990 after preparing the proper seizure list duly signed by them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of India vide Order No. 40-3/2020-DM-1/(A) Dtd. 01.05.2020 read with order of Govt. of West Bengal Vide Memo No 103-CS/2020 dtd. 04.05.2020 and did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life for themselves and others and their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life of themselves and others so they can be booked u/s 188/269/270 of the IPC & 51 of the National Disaster Management Act, 2005 and 3 of the Epidemic Diseases Act 1897. So a specific case may kindly be initiated against them and arranged for its investigation.
