With due respect and humble submission I beg to state that I am Bipan Lohar S/o Late Dhananjoy Lohar of Babugram, PS Raghunathpur, Dist-Purulia.

I beg to inform you that today i.e. on 06/06/2020 at about 09:00 hrs while my nephew namely Silpi @ Shiuli Lohar (4 Years) D/o Tapas Lohar of Babugram, PS Raghunathpur, Dist-Purulia was walking by the side of the road via Raghunathpur – Santaldih main Road and when she reached near Punjab National Bank, Babugram under Raghunathpur PS at that time one Bolero Vehicle having Registration No. WB38AR/1731 dashed her, which was coming from Raghunathpur side.

As a result ~~my~~ nephew received serious bleeding injury on her person and shifted her to Raghunathpur Super Specialty Hospital where she declared dead by the attending doctor after treatment. Over this started Raghunathpur PS UD Case No. 37/2020 dated 06/06/2020. This only happened due to rush and negligent driving by the driver of the offending Bolero Vehicle having Registration No. WB38AR/1731.

So, I therefore, pray before you kindly take necessary legal action against the driver of the offending Bolero Vehicle having Registration No. WB38AR/1731 and also seized the said car.
