With due respect, I am to report that today (09/06/2020) at 15:35 hrs received one telephonic information from one CV/Subir Kr Mahato of Vill.-Chatarmahal under Joradih G.P, that one Devi Prasad Mahato (37) S/o Madhusudan Mahato of Chatarmahul, PS - Raghunathpur, Dist.- Purulia came from Tamilnaru on 05/06/2020 and he was medically checked-up at Banda BPHC Flue Corner, where on duty MO advised him to stay at Institutional Quarantine as per Govt. Order and as such he was put into the Chatarmahul Pry. School for his Quarantine, but he did not pay any heed to the Govt. Order as well as advice of MO and moving aimlessly here and there in his village Charatmahul. After getting such information said CV of same village tried to understand him but he also failed to pacify him.

After getting such information, as per order of IC Raghunathpur PS, I, SI Jayanta Kumar Chakraborty left to work out the information after diaries the fact in General Diary vide Raghunathpur PS vide GDE No. 416 dated 09/06/2020 and directed VP Satyajit Roy of Joradih GP to accompany with me.

At about 16:15 hrs I had been to village Chatarmahul with VP Satyajit Roy and enquired into the matter locally in presence of said CV and some other disinterested people. During enquiry I visited the house of Devi Prasad Mahato and found he was available in his house and not willing to stay at Chatarmahul Pry. School on my request and fled away.

So, it is well established that he is violating the rules and norms as per Govt. order in this pandemic Covid-19 situation vide Memo No H&FW/173/20 dated- 27/05/2020 of Govt. of West Bengal, Health and Family Welfare and will responsible for spreading the deceased in the community.

I, therefore, pray before you, necessary legal action may kindly taken against the said Devi Prasad Mahato (37) S/o Madhusudan Mahato of Chatarmahul, PS - Raghunathpur, Dist.- Purulia by registering a case under proper section of law and thus obliged.
