Sub: Request for lodging FIR against arrested accused persons.

Sir,

In producing herewith 03 (three) arrested accused persons namely (1) Rabi Bauri (22) S/o Yudhisthir Bauri of Vill.- Kashiberia, PS – Raghunathpur, Dist.- Purulia, (2) Dipak Bauri (23) S/o Basudeb Bauri of Do and (3) Kalipada Bauri (24) S/o Balaram Bauri of Do along with seized Motor Cycle, Seizure List, Memo of Arrest, Inspection Memos & other relevant papers.

I beg to state that today (i.e. 27/06/2020), I was directed to find out whether the lock down has been properly implanted at Raghunathpur Market area or not and also directed to intercept the triple rider in an one Motor Cycle. This refers to Raghunathpur PS GDE No. 1234 dtd. 27/06/2020. Accordingly during my mobile duty, I along with force had been to Raghunathpur Traffic More and started Naka Checking from 21:15 hrs.

At about 21:35 hrs we intercepted one Motor Cycle having Reg. No. WB 38X/8887, which was coming dangerously from Raghunathpur Bus Stand side with 03 (three) persons in an one Motor Cycle without using headgear. After intercepting I asked their identity and also directed to produce documents in respect of the motor cycle.

During examination they disclosed their identity as noted above, but at present they failed to produce any documents in respect of said Motor Cycle and accused Dipak Bauri told that all the papers in respect of the motor cycle are kept at his home and will be produce later on. I also asked them the reasons of movement in the lock down period by riding in an one mother cycle dangerously and indiscipline manner, but they failed to give any satisfactory answer and started to incoherent statement regarding their movement. As such they disobedience to order duly promulgated by Govt. through public servants and through media etc. for prevention of attack from Corona Virus /Covid-19. They are also creating annoyance to the Society & violated Govt. Order. As such I arrested them after maintain all the formalities as per law and narrating them the ground of arrest and also seized the said motor cycle having Reg. No. WB 38X/8887 from the possession of accused Dipak Bauri in presence of other two accused persons after preparing proper seizure list.

There was every chance of breach of peace and requiring of offence if not arrested them as there was lock down in the town. The people left the place and did not agreed to come forward to remain present in the seizure process.

After that myself left for PS. On arrival at PS I arrange to type this letter of complaint at our PS computer and submitted to IC Raghunathpur PS for taking necessary action as per law. I also handed over all relevant papers, seizure list, seizure motor cycle, memo of arrest & Inspection Memo.
