



The complainant most respectfully begs to state :-

1. That the accused No. 1 Soma Acharjee is the married wife of the complainant and the marriage between the complainant and the accused No. 1 was solemnised in the year 2006 as per Hindu rites and customs.
2. That after marriage the complainant and the accused person No. 1 started living as husband and wife in the residence of the complainant at village-Manduara, P.S. Raghunathpur, District-Purulia and by this coverture they blessed a male child now aged about 7 years namely, Ayush Acharjee.

3. That the complainant has got his family consisting of his wife, the accused No. 1 ~~his~~ ^{and} above named son and his old ailing parents.

4. That the accused No. 2 is a resident of same village Manduara and resides nearby the residence of the complainant and used to maintain visiting terms with the family of the complainant which paved the way of develop intimacy with the accused No. 1.

5. That since recent past it is notices by the complainant that the behaviour and manner of the accused No. 1 started becoming indifferent towards the domestic work and towards the complainant and his son as well which shattered the confidence of the complainant towards the accused No. 1.

6. That in pursuance of the above facts and circumstances the complainant started keeping watching eye to the daily routine of the accused No. 1.

7. That it is to be submitted that the complainant runs a Business with mike and light and for that he has to remain outside at night while his mike and light is taken by the other on hire.

8) That on the date of occurrence the complainant was ~~also~~ absent from his house due to his above said business and at about 9 P.M. the complainant was informed from reliable sources that the accused No. 2 is staying in the house of the complainant and in pursuance of that the complainant came back to his residence and saw that the bed room of the complainant was closed by bolting the door from inside and started calling the accused No. 1 for opening the door in a loud voice and knocked the door time and again but in no good.

9. That the complainant having no way broke open the door with the help neighbours and the witnesses who attended the house of the complainant hearing hulla and saw that the accused No. 1 and accused No. 2 had been comming out from the bed room of the complainant so it is evident that the accused No. 2 has committed the offence of adultery with the active co-operation and instigation of accused No. 1 in collusion of each other criminally house trespass in criminal conspiracy of each other.

10. That it is to be submitted that the complainant and others tried to catch hold the accused No. 2 but the accused No. 2 saved himself from that and fled away and the accused No. 1 also fled away from the residence of the complainant to her parents' house which is situated in the same village at Nanduara.



11. That the accused No. ~~1~~ ~~is the wife~~ of the complainant starting holding out in the locality that the complainant drove her away from his residence and she will booked the complainant in the provisions of law if the complainant take any action against the accd. persons.

That ~~she~~ on the following morning of the occurrence the complainant with a written complaint attended Raghunathpur P.S. and lodged the same but the Police of Raghunathpur P.S. did not take any action against the accused persons and while the police took no action the complainant lodged the complaint before S.P. Purulia through registered post with A/D and still then no action has been taken till his date so the complainant came before your honour's court.

It is therefore prayed that your honour may please be gracious ~~in~~ enough to sent this complaint to a/c, Raghunathpur P.S. for investigation and treating this complaint as F.I.R. u/s 156(3) Cr.P.C. for ends of justice.
