Sir,

In producing herewith one accused person namely Akash Gorai (19 Yrs.) s/o Krishna Gorai of Manogram, PS – Raghunathpur, Dist - Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 10 (Ten) sealed bottles (CS) containing 600 ml each and labeled with DILKHUSH.
- 2) 05 (Five) sealed bottles (CS) containing 375 ml each and labeled with DILKHUSH.
- 3) 05 (Five) sealed bottles (CS) containing 600 ml each and labeled with CAPTAIN.
- 4) Cash Rs. 70/- (Seventy) as sale proceed.
- 5) One big size nylon bag.

I do hereby lodge this complaint regarding that today 21.01.16 at about 19:35 hrs during my special raid duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely in front of his Line Hotel beside the main road on Raghunathpur – Santaldih road. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/200 Dasarath Mahato and C/1434 Jagannath Mondal rushed to the spot to work out the information. On arriving to the spot, I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Akash Gorai (19 Yrs.) s/o Krishna Gorai of Manogram, PS – Raghunathpur, Dist - Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
