Sir,

In producing herewith the arrested accused person Jamaluddin Molla (49) s/o Lt Jalil Molla of Chakpur, PS - Rajarhat, Dist - North 24 Parganas, Khalasi of vehicle No. WB 55A/2217 loaded with scrap iron approx 5 (five) MTs with above noted vehicle. Fact of the case in brief is that on 24.01.17 myself along with C/562 Narayan Ch Gorai and C/405 Pashupati Sarkar who were on evening patrolling duty on Raghunathpur - Chelliyama road and received a source information that the above noted vehicle is coming loaded with scrap iron from Chelliyama side towards Raghunathpur side. After receiving this information we had been to Raghunathpur - Chelliyama road at Rakshatpur more and found that the above noted vehicle loaded with scrap iron is coming from Chelliyama side. We stopped the said vehicles thereafter driver of the said vehicle was fled away but found that the Khalasi of the said vehicle is present in this vehicle and asked the Khalasi to produce the authentic papers in respect of said scrap iron as well as papers in respect of this vehicle but he failed to produce any papers of the said vehicle and loaded scrap iron. He also stated that the said scrap iron was loaded from Kulsora area. The Khalasi also confessed his guilt implicating himself, driver and owner of the said vehicle who were involved into this case. The Khalasi also stated that they are running a clandestine business through this scrap iron for wrongful gain and they are habitual to running this business. As such it is every reason to believe that the Khalasi, driver, owner of the said vehicle No. WB 55A/2217 with ill motive were transporting scrap iron illegally and they are liable for offence punishable U/S 379/411/413/414 IPC. As such I arrested the accused Khalasi namely Jamaluddin Molla (49) s/o Li Jalil Molla of Chakpur, PS - Rajarhat, Dist - North 24 Parganas issuing arrest memo and inspection memo, observing other guide lines of Supreme Court and Human Rights Commission. I also seized the vehicle No. WB 55A/2217 loaded with approx 5 (five) MTs scrap iron preparing seizure list in presence of my accompanied staffs. No public witness was available there.

I therefore pray that kindly start a case against accused Khalasi namely Jamaluddin Molla (49) s/o Lt Jalil Molla of Chakpur, PS - Rajarhat, Dist - North 24 Parganas, driver and owner of the said vehicle No. WB 55A/2217 as per law and arrange its investigation.
