Dear Sir,

Yesterday, i.e., on 26.01.17 at about 10.00 am it had detected that one Distribution Transformer of 150 KVA is completely damaged and copper winding coil of the transformer is theft by unknown miscreant near Maa Sarada Enterprise at Limpo, Barakar-Purulia Road, PS- Raghunathpur, Dist- Purulia. The said Transformer has been damage by drain out the oil and cutting the core of transformer then stole the copper winding coils of said transformer.

A loss of property of W.B.S.E.D.C.L. has been incurred by this incident which comes approximately Rs.156232.00(one lacks fifty six thousand two hundred thirty two only)including material loss and labor loss,by considering 40% depreciation on principal amount of material.

Among that they stole copper of worth approximately Rs. 54600.00(fifty four thousand six hundred only),and damage value is approximately Rs.102000.00(one lack two thousand only)
