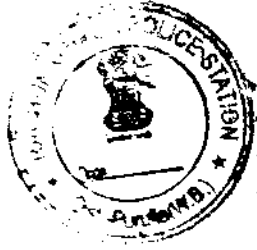

Sir,

In producing herewith the arrested accused person Makeswar Paswan (55), S/o. Lt Situ Paswan of Vill.- Lachmipur, PS – Surujgadha, Dist – Lakhisarai (Bihar), A/P – Dendua Morh, PS – Salanpur, Dist – Burdwan, driver of truck No. WB 41/9548 loaded with stolen dust coal approx 12 MTs with above noted vehicle. Fact of the case in brief is that on 28.01.17 myself along with C/21 Sk Roshan and C/129 Haripada Rajwar who were on evening mobile duty on Purulia – Barakar road and received a source information that the above noted vehicle is coming loaded with dust coal from Barakar side towards Raghunathpur side. After receiving this information we had been to Purulia – Barakar road at Kelahi Jangle and found that the above noted vehicle loaded with dust coal is coming from Barakar side. We stopped the said vehicles and asked the driver to produce the authentic papers in respect of said dust coal as well as papers in respect of his vehicle and his driving license but he failed to produce the papers and driving license. He also stated that the said coal was loaded from Maithan area (Jharkhand). The driver also confessed his guilt implicating himself and owner of the said vehicle who were involved into this case. The driver also stated that they are running a clandestine business through this coal for wrongful gain and they are habitual to running this business. As such it is every reason to believe that the driver, owner of the said truck No. WB 41/9548 with ill motive were transporting dust coal illegally and they are liable for offence punishable U/S 379/411/413/414 IPC. As such I arrested the accused driver of above noted vehicle after observing all formalities regarding his arrest. On interrogation he disclosed his identity as noted above. I also seized the truck No. WB 41/9548 loaded with approx 12 MTs Dust Coal under proper seizure list duly signed by the accused driver and witnesses. No public witness was available there.

I therefore pray that kindly start a case against accused person namely Makeswar Paswan (55), S/o. Lt Situ Paswan of Vill.- Lachmipur, PS – Surujgadha, Dist – Lakhisarai (Bihar), A/P – Dendua Morh, PS – Salanpur, Dist – Burdwan and owner of the said truck as per law and arrange its investigation.
