In producing herewith the accused persons namely (1) Sk Ibrahim s/o/Lt Sk Hamidul of Balichura, Ward No 5, PS - Raghunathpur, Dist - Purulia, 2) Sk Imran s/o Sk Ibrahim of Do and 3) Kartik Debnath s/o Manik Debnath of Pratapnagar, Monimala Lane, Ward No 5, PS - Nabadwip, Dist - Nadia under arrest and seized articles 1) One packet of Cannabis/Ganja weighing 8.330 Kgs., 2) One packet of Cannabis/Ganja weighing 8.280 Kgs., 3) One packet of Cannabis/Ganja weighing 8.260 Kgs., 4) One big size bag having black colour with red lining, 5) One School bag of Violate colour, 6) One black & red Bajaj discover motorcycle having Reg. No. WB 56G/5822, 7) Cash of Rs. 30,000/- (Thirty Thousand) of denomination of (a) Rs. 100 X 200 Nos. = Rs. 20,000/-, (b) Rs. 20 X 270 Nos. = Rs. 5400/- & (c) Rs. 10 X 460 Nos. = Rs. 4600/- under proper seizure list sealed and level duly signed by the witnesses and accused persons, I'SI Pankaj Singh, O/C Raghunathpur PS do hereby lodge this complaint suo-motu against the above noted three accused persons for committing an offence punishable U/S 20 (b)(i)/29 NDPS Act 1985. Today (23.02.17) at 11:45 hrs. received a reliable source information to the effect that one drug peddler of Nabadwip under Nadia district will come to Joychandi Station area with huge quantity of Cannabis/Ganja by availing Burdwan - Purulia local train which is expected to arrive at 12:30 hrs at Joychandi Railway Station with a view to sale the same to some local peddler. My source also informed that 02 (two) drug peddler of Raghunathpur area namely 1) Sk Ibrahim & 2) Sk Imran riding on a black red Bajaj Discover motorcycle having Reg. No WB 56G/5822 are likely to meet the said drug paddler of Nabadwip area with a view to receive the said Cannabis/Ganja in lieu of money in a place adjacent to Joychandi Station area. The source also mentioned that said drug peddler of Nabadwip, aged about 21 years, wearing denim jeans & yellow full shirt (Square check) who has in possession one violet colour school bag on his back & another big size black coloured bag in his hand, both containing packets of Cannabis/Ganja. Accordingly, I noted the fact in G.D. vide Raghunathpur PS GDE No 1065 dtd 23.02.17, informed the matter to CI, Raghunathpur & SDPO, Raghunathpur, and other Superiors Officers of Purulia District. As per their direction myself along with my source ASI Prabir Kr. Dey, SI Gopal Bhattacharya, C/496 Prakash Ch. Mahato, C/38 Parbati Ch. Mudi, C/08 Tapan Kr Mahato vide C.C. No. 796 dtd 23.02.17 left for Joychandi Station area to work out the information by Govt. vehicle having Reg. No. WB 56B/4921 also carried seal, gala, match box, candle, brown paper, weighing instrument.

Today at 12:05 hrs reached near Joychandi Railway X-ing with in a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle in a hiding place, we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road approaching to the Joychandi Station. At about 12:15 hrs one motorcycle rider, identified as Sk Imran with pillion rider duly identified by source as Sk Ibrahim with black red Bajaj Discover motorcycle having Reg. No. WB 56G/5822 arrived at the pacca road just beside the Platform No 1 of Joychandi Station. We watched them for a considerable period, meanwhile, the Burdwan – Purulia local train arrived at Joychandi Station at about 12:35 hrs. After a while, one youth as per description of the source came out from the railway station with two bags, one of them is violet coloured school bag on his back and other one is a big sized black coloured bag in his hand was approaching towards the place where Sk Ibrahim and Sk Imran were waiting for him. Reaching to them, the said youth handed over the school bag to Sk Imran & big size bag to Sk Ibrahim. Sk Imran also handed over a small packet to the said youth who kept the packet inside his shirt. Watching

this, I along with accompanied officers & force disclosing our identities surrounded them & also detained them with the said bags at 12.55 hrs. On being asked the youth disclosed his identity as Kartik Debnath s/o Manik Debnath of Pratapnagar, Monimala Lane, Ward No 5, Nabadwip, PS -Nabadwip, Dist - Nadia & other two persons who were already identified as above disclosed their full particulars as 1) Sk Imran s/o Sk Ibrahim, 2) Sk Ibrahim s/o Lt Sk Hamdul both of Balichura, Ward No 5, PS - Raghunathpur, Dist - Purulia. On interrogation, the said Kartik Debnath also confessed that the both bags contained Cannabis/Ganja. He also stated that, as per direction of one Buro @ CD Buro of his area he came here to hand over the said Cannabis/Ganja to Sk Imran & Sk Ibrahim and also collect the price value of said Cannabis/Ganja in cash. On further interrogation at PO, said Sk Imran and Sk Ibrahim agreed with the fact & also stated that they have business transaction with said Buro @ CD Buro since long. They sale the said Cannabis/Ganja to the retailers of Purulia District. Informed the matter to Cl, Raghunathpur and SDPO, Raghunathpur. Thereafter, I issued notice to all three accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, all three detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate accordingly sent requisition to the SDO, Raghunathpur with a request to depute an Executive Magistrate for search and seizure as per provision of section 50 of NDPS Act. Meanwhile, we searched for public witnesses with the help of accompanied officer & force. After a while two public witnesses namely 1) Amal Dhibar s/o Archan Dhibar of Vill.- Biltora, PS - Raghunathpur, Dist - Purulia, 2) Sukumar Gorai s/o Bhikuram Gorai of Tantipara, Ward No 3, PS - Raghunathpur, Dist - Purulia became ready to assist us in conducting search & seizure. Within half an hour CI, Raghunathpur & SDPO, Raghunathpur, Kaleswari Kora, DMDC, Raghunathpur arrived at the spot and disclosed their identity and explained the reason for arriving there. After their arrival I started search & seizure process at PO. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Kaleswari Kora, DMDC, Raghunathpur, Executive Magistrate and detained persons. At first myself with the help of officers and force searched Sk Ibrahim and his belonging at the spot. During search of him, one bag loaded with 02 (two) packets wrapped with polythene paper each weighing 8.330 Kg and 8.280 Kg. Thereafter as per direction of Executive Magistrate I opened some portion of both packets and found Cannabis/Ganja in each packet. Accordingly I seized the big size bag having black coloured red lining and 02 (two) packets Cannabis/Ganja weighing 8.330 Kg and 8.280 Kg under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of Executive Magistrate. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused person. Then I conducted search of Sk Imran and his belonging at the spot. During search of him one violate coloured school bag containing one packet wrapped with polythene paper weighing 8.260 Kg. After taking permission from Executive Magistrate I opened some portion of the packet and found Cannabis/Ganja inside the packet. Accordingly I seized the violate coloured school bag and packet of Cannabis/Ganja weighing 8.260 Kg and one black & red Bajaj Discover motorcycle having Reg. No WB 56G/5822 under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of Executive Magistrate. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy

of seizure list to the accused person. Then I with the help of officers and force searched Kartik Debnath and his belonging and found Cash of Rs. 30,000/- (Thirty thousand) of denomination of (a) Rs. 100 X 200 Nos. = Rs. 20,000/-, (b) Rs. 20 X 270 Nos. = Rs. 5400/- & (c) Rs. 10 X 460 Nos. = Rs. 4600/- inside his shirt and he stated before us that the said cash paid by Sk Imran as partial cost of the Cannabis/Ganja, duly delivered by him to Sk Ibrahim and Sk Imran. Accordingly I seized the same under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of Executive Magistrate. Also packaged, sealed and leveled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused person. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrest all of them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and leveling were done between 15:05 hrs and 18:55 hrs under direct supervision of Smt Kaleswari Kora, DMDC, Raghunathpur, Executive Magistrate, SDPO, Raghunathpur and CI, Raghunathpur.

I started this case Suo-motu against the accused persons namely 1) Sk Ibrahim s/o Lt Sk Hamidul of Balichura, Ward No 5, PS – Raghunathpur, Dist – Purulia, 2) Sk Imran s/o Sk Ibrahim of Do, 3) Kartik Debnath s/o Manik Debnath of Pratapnagar, Monimala Lane, Ward No 5, PS – Nabadwip, Dist – Nadia and 4) Buro @ CD Buro s/o Not Known of Do U/S 20(b)(i)/29 NDPS Act 1985 and directed SI Probodh Kr Mondal for its investigation.
