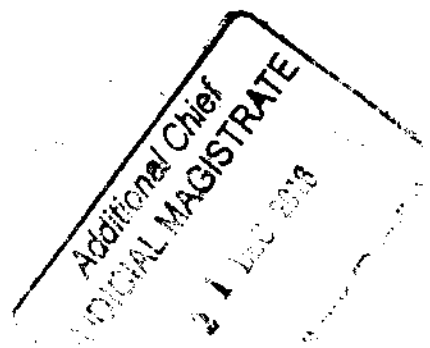

That on the day of incident at relevant of point of time all the Accd. persons in order to fulfill their ulterior motive in furtherance of their common intention all the accd. person all on a sudden after forming unlawful assembly and having armed with deadly weapons trespassed into the house of the complt, and began shouting with filthy language " *माता माता धुशकाया, प्रिये लया जाके धुशकाया । (क शब्द जाले देता* ". Accd. namely Dukhu Mia @ Andary was armed with an axe, Abedan Bibi was having armed with a Iron rod , Teria khatun attempted with a sickle and rest Accd was <sup>with</sup> a lathi. Seeing the Accd in so desperate and in <sup>head</sup> teeth claws your complt tried to raise protest in which all the accused persons grew furious and attempted to assault the complt. With an intention to inflict grievous injury to the person of the complt, but complt any how escaped himself from the clutches of the Accd. persons . All the other witnesses also came to the P.C. ~~of the area~~ and witnessed the illegal & overt act of the Accd. persons even they also raised protest against such illegal act of the Accd persons but Accd person who are so rude and desperate also threatend the complt and witness with dire consequences.

4. That all the accd. persons also ranshaked the dwelling place of the complt. by breaking their bamboo fencing causing a damage of Rs. 1500/- and onwards then they left the P.C.

That due to such desperate act of the Accd. persons your complt and his other family members have sustained injury ~~xxx~~ mentally of being murdered by the Accd. person On opportune moment, ~~so~~ finding no other alternative ~~xxx~~ your complt, informed the matter through written complaint within
