

That on the day of incident at relegant of point of time all the Accd. persons in order to fulfill their ulterior motive in furtherance of their common intepytion all the accd. person all on a sudden after forming unlawful assembly and having armed with deadly weapons tresspassed into the house of the complt. and began shouting with filthy language " ~~کیا اپنے بھائیوں کی کامیابی کیلئے جسے وہ اپنے بھائیوں کیلئے کیا~~ ". Accd. namely Dukhu Mia & Andary was armed with an axe. Abedan Bibi was having armed with a Iron rod , Teria Khatun attempted with a sickle and rest Accd was ~~the~~ ^{with} a lathi. Seeing the Accd in so desperate and ^{red} inateeth claws your complt tried to raise protest in which all the accused persons grew furious and attempted to assault the complt. with an intention to inflict grbevious injury to the person of the complt, but complt any how escaped himself from the clutches of the Accd. persons . All the other witnesses also came to the P.C. ~~of the accd.~~ and witnessed the illegal & overt act of the Accd. persons even they also raised protest against such illegal act of the Accd persons ~~but Accd persons~~ who are so rude and desperate also threatend the complt and witness with dire consequences.

4. That all the accd. persons also ranshaked the dwelling place of the complt. by breaking their bamboo fencing causing a damage of Rs. 1500/- and onwards then they left the P.C.

5. That due to such desparate act of the Accd. persons your complt and ~~this~~ other family members have sustained injury ~~and~~ mentgally of being murdered by the Accd. person On opportune moment. So finding no other alternative~~and~~ your complt. informed the matter through written complaint within

accd person but local P.S. had not taken any step against such grievances of the complt. there after your complt. also informed the matter to the S.P.Purulia though Regd. post on 25/11/2016 for his remedy but no action has yet been taken ~~at~~ the instance of S.P.Purulia ^{this} ~~within~~ regard . Whereas Accd also roaming in the locality with theire head held high inspite of doing such illegal act.

It is therefore prayed that Ld. court may kindly be pleased to direct the O/C , Raghunathpur P.S. to investigate the matter after treating the same as F.I.R.
