## To The Officer – in charge Raghunathpur P.S.

Sir.

In producing herewith the arrested accused person namely Sanjoy Gorain s/o Manohar Gorain of Biltora, PS – Raghunathpur, Dist - Purulia alongwith seized articles 1) One country made pipe gun, 2) two rounds live .8 mm cartridges to the fact that today (08.03.17) at 21:45 hrs. while I was engaged in special raid duty, received credible source information that one person namely Sanjoy Gorain, aged about 21 years, being equipped with fire arms, moving around Biltora Morh area with ill motive. I also took descriptions of the person and his wearing apparels (Green colour full T-Shirt and Blue colour Jeans Pant). Accordingly I informed the matter to O/C Raghunathpur PS and as per his direction I left to work out the information. On way I briefed my accompanied staff about the description of the suspect Sanjoy Gorain and the mode of action to be done during detention. At 22:15 hrs. we reached near Biltora morh area and kept the Govt. vehicle 200 meters away from Biltora Morh and ambushed ourselves in a dark side area. After few minutes, according to the source information, we intercepted one person as described above, disclosing our identity.

On being asked the person disclosed his name and address as Sanjoy Gorain s/o Manohar Gorain of Biltora, PS – Raghunathpur, Dist - Purulia. On being searched of his person one country made pipe gun loaded with one round live 8 mm could be recovered from his left waist and one live cartridge of 8 mm also found his left pocket. On demand he failed to produce any valid document in respect of possession of arms and ammunition. He also confessed that he had procured the same to commit robbery at Raghunathpur – Bankura road near at Biltora village. As such for committing an offence punishable U/S 25(i)(a) Arms Act. Hence, I arrested him issuing arrest memo, informed ground of arrest and other guidelines regarding arrest. Then, I seized one country made pipe gun and 2 live .8 mm cartridges from his possession under proper seizure list duly signed by the above noted accused person and police witnesses. No public witnesses were available there at P.O. at that time.

I therefore pray before your that kindly start a case as per law and arrange its investigation.
