In producing here with the arrestee Sabir Mir (38) s/o Lt Mir Abdar Sattar of Vill.- Raidih, PS - Raghunathpur, Dist - Purulia along with one seized Red & Black colour Hero Honda Passion Pro Motor cycle bearing registration No WB 54G/1496 (Tampered Number Plate), Chachis No -MBLHA10EWBHH44271, Engine No - HA18EDBH46488 under proper seizure list duly signed by the witnesses, I, ASI Prabir Kr. Mukherjee of Raghunathpur PS do here by lodge a written complaint against the above named arrestee who was only rider of the said motorcycle, I would like to inform you that on 10.03.17 at about 17:55 hrs while myself accompanied with C/08 Tapan Mahato, C/21 Sk Roshan of Raghunathpur PS were performing anti crime Naka checking duty on Raghunathpur - Bankura road near at Madhutati Morh under Raghunathpur PS and found the above named person was coming from Hero side by his motorcycle as stated above. On seeing the police party the said rider tried to change his direction to flee away. After hot chase we able to apprehended him and asked him to produce documents in respect of possession of such motorcycle and why he tried to flee away? On demand he neither produced any valid documents in this regard nor answered why he changed his direction and fleeing away. I offered him also to call his near relatives, to produce the documents in favour of the said motorcycle if any, but he did not agree with my proposal. Moreover he made different statements in different times regarding his identity as well as keeping possession of such motorcycle. After long interrogation he disclosed his identity as stated above and informed me that he was trying to conceal the motorcycle and disperse the same to his well known persons. Hence there is adequate reason to belief that the said motorcycle was stolen one and the accused Sabir Mir was dealing with motorcycle for the purpose of business after knowing it to be a stolen one and concealed the same for his business. Accordingly I seized the motorcycle bearing registration No WB 54G/1496 (Tampered Number Plate), Chachis No - MBLHA10EWBHH44271, Engine No -HA18EDBH46488 after furnishing seizure list maintaining all formalities and I arrested him after maintaining all legal formalities of arrest.

Under the above facts and circumstances I therefore pray that necessary steps may kindly be taken against accused person Sabir Mir under proper section of law.
