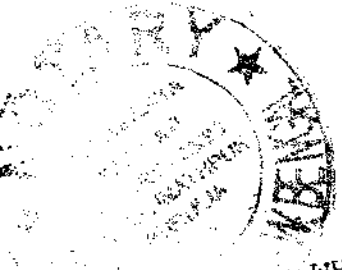

- 5) That the the second party will also not marry with any other person for the second time without being divorced lawfully by the first party through the competent court of law.

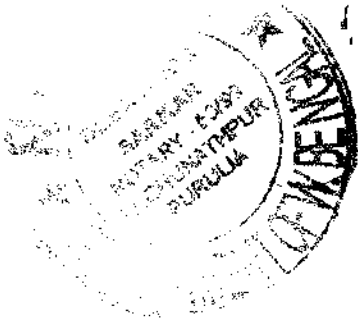
